


The reported resolution of this entry is 3.35 Å.

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion < 40%). The numeric value is given above the bar.



2 Entry composition i

There are 5 unique types of molecules in this entry. The entry contains 19635 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

















8 Fourier-Shell correlation [\(i\)](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. 




