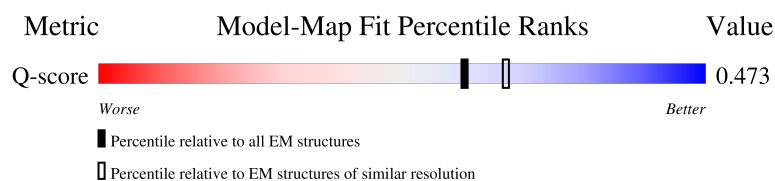
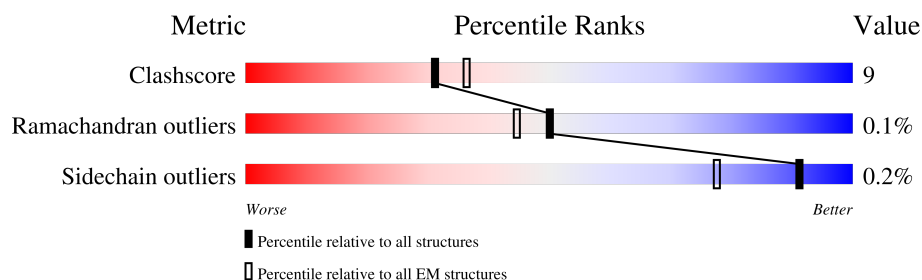
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.50 Å.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

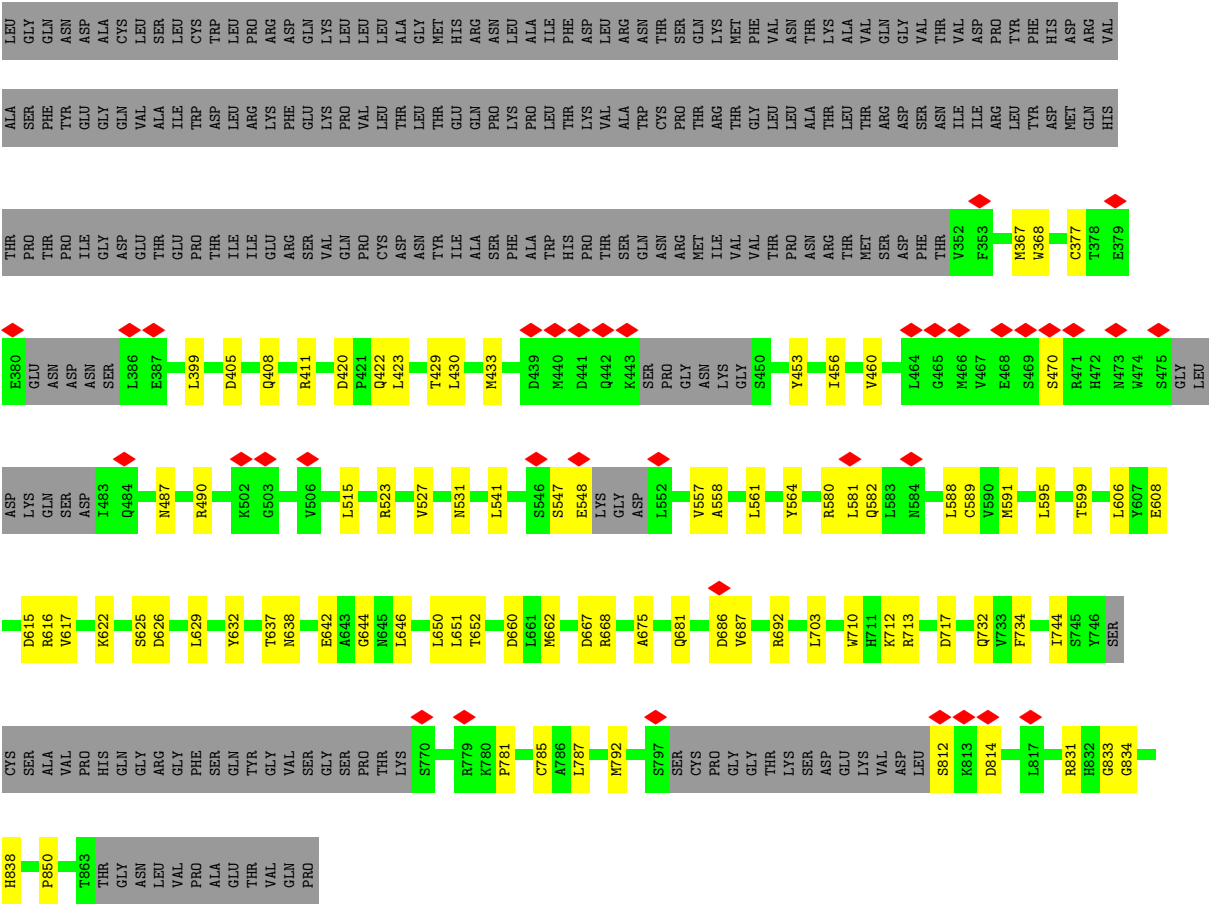


• Molecule 1: GATOR2 complex protein MIOS

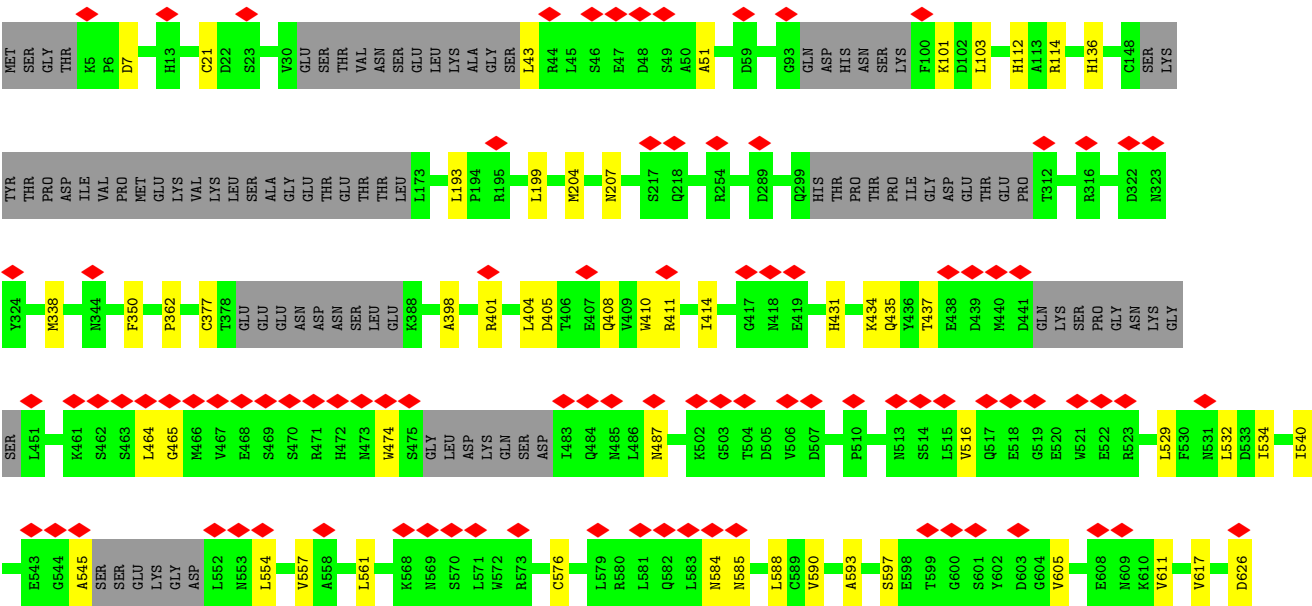


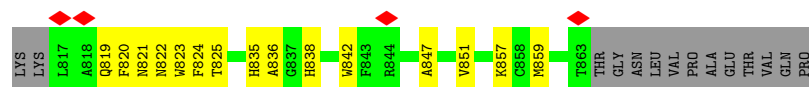

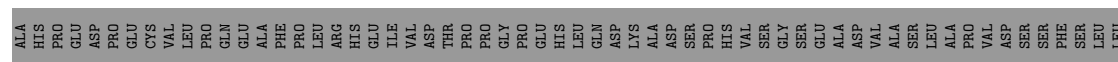
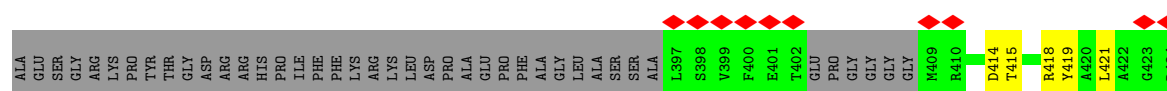


• Molecule 1: GATOR2 complex protein MIOS

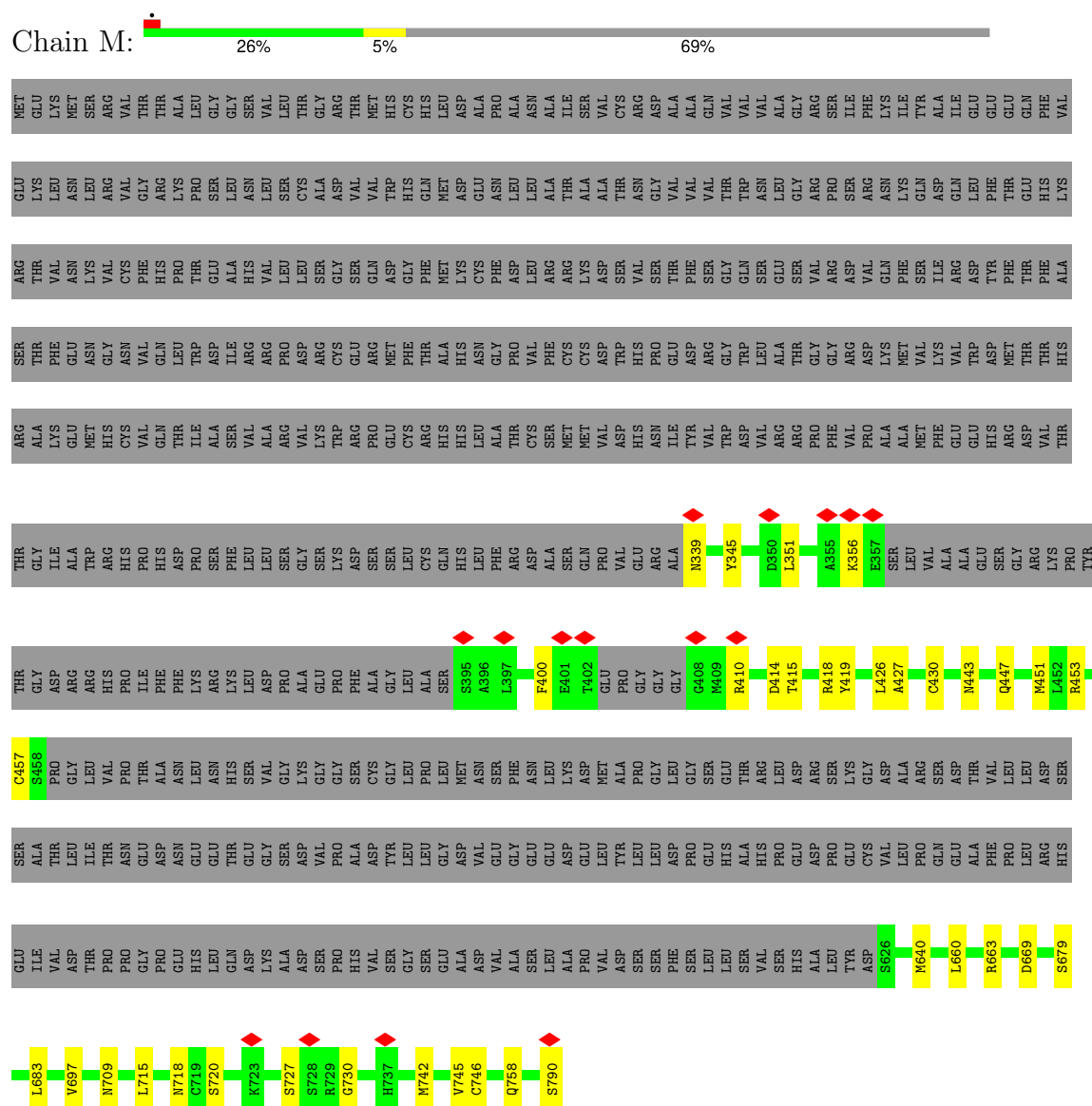




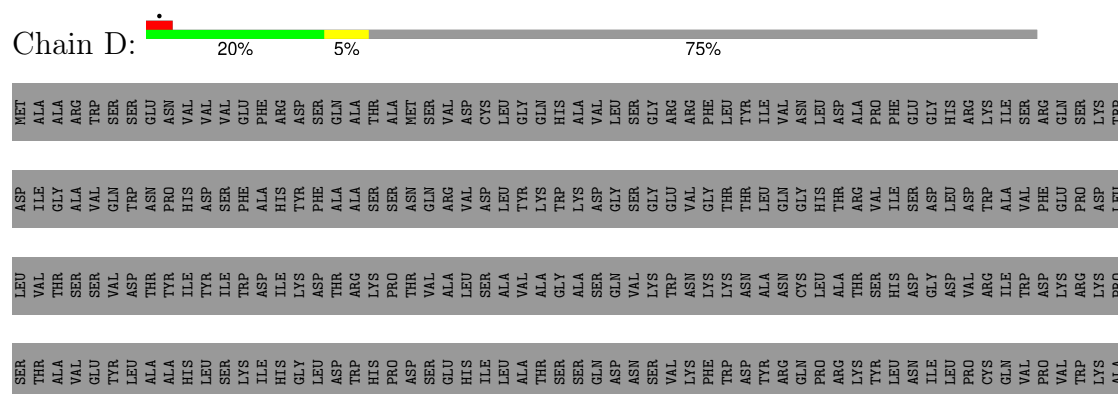
- Molecule 2: GATOR complex protein WDR24

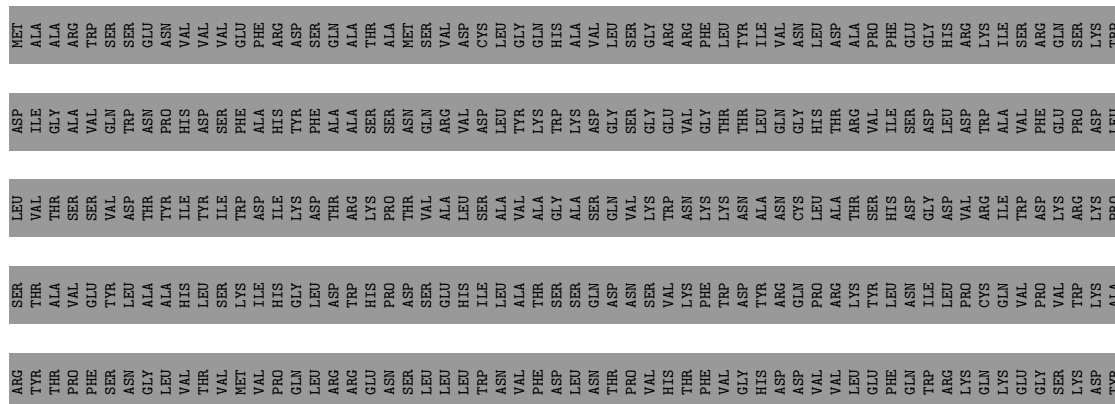
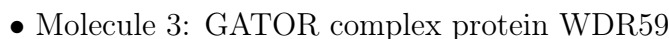

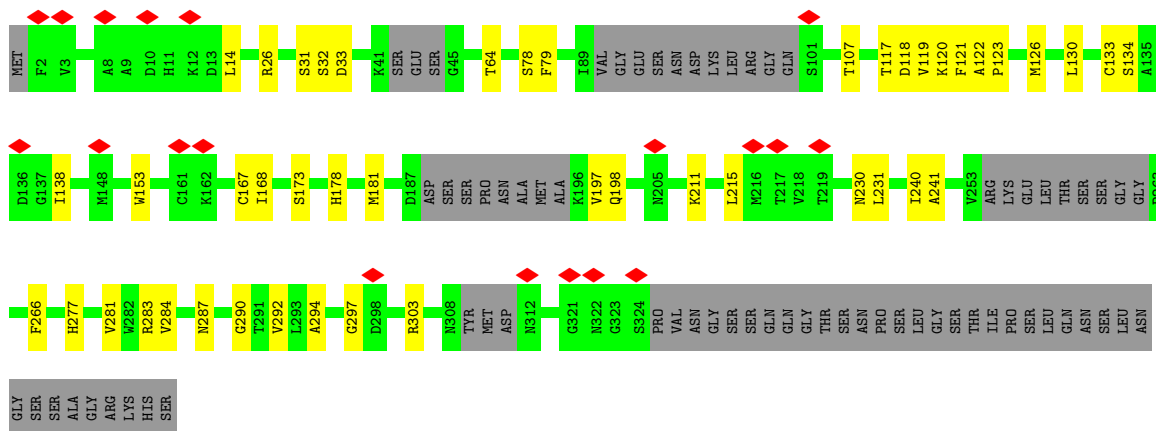


• Molecule 3: GATOR complex protein WDR59

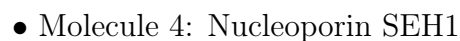


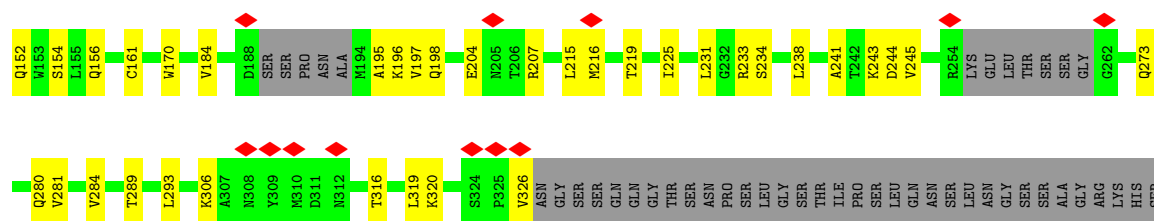


- Molecule 4: Nucleoporin SEH1

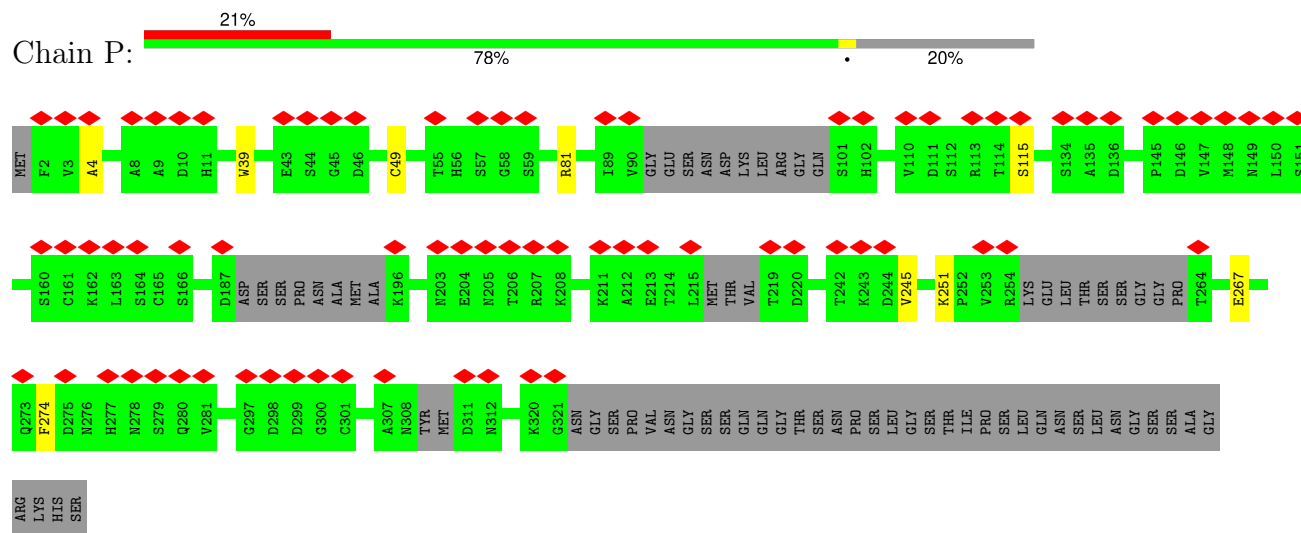

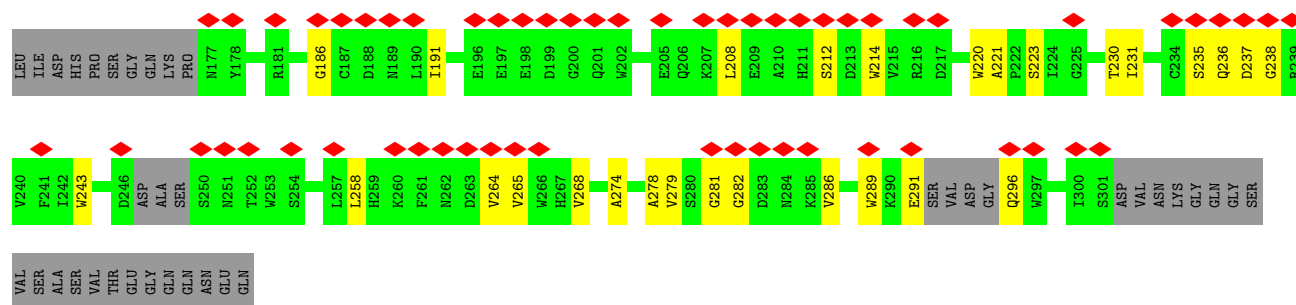

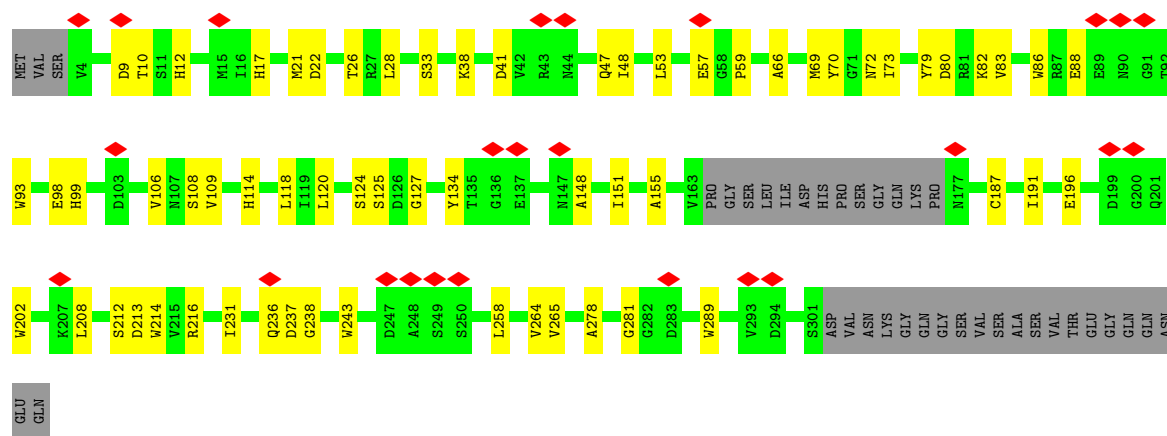


• Molecule 5: Protein SEC13 homolog

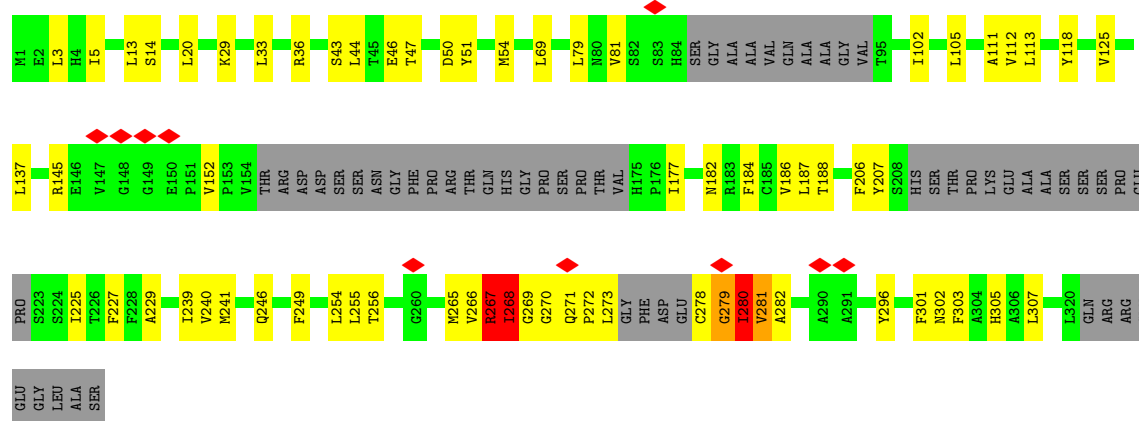

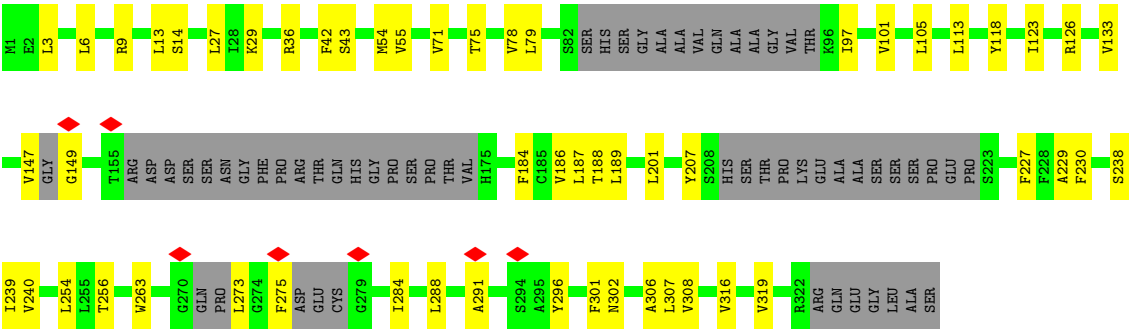


• Molecule 6: Cytosolic arginine sensor for mTORC1 subunit 1

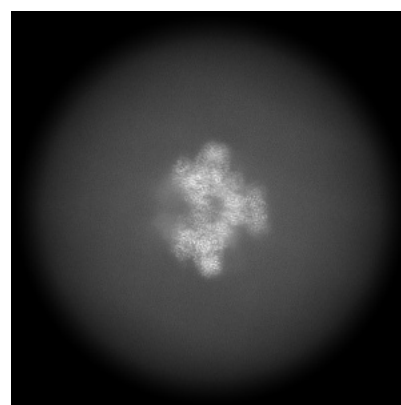

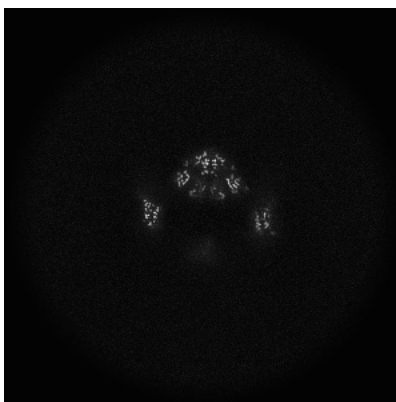

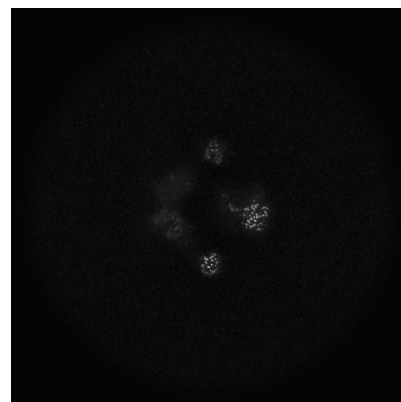

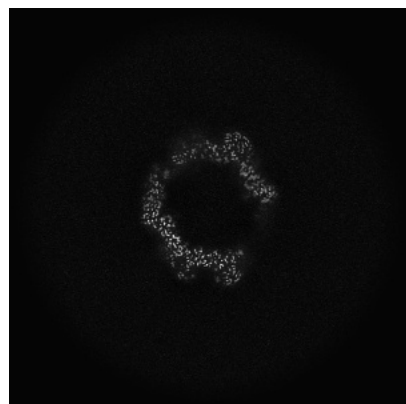

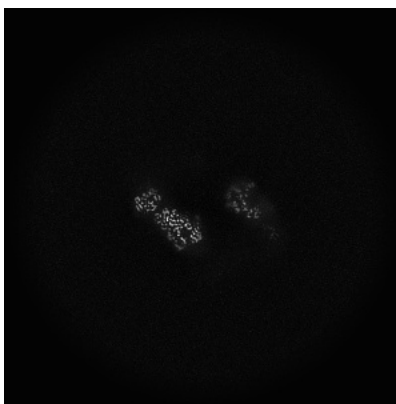
The images above show central slices of the map in three orthogonal directions.

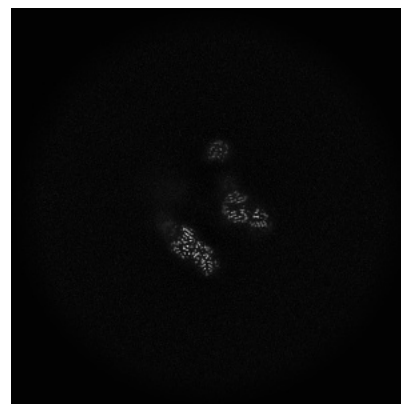

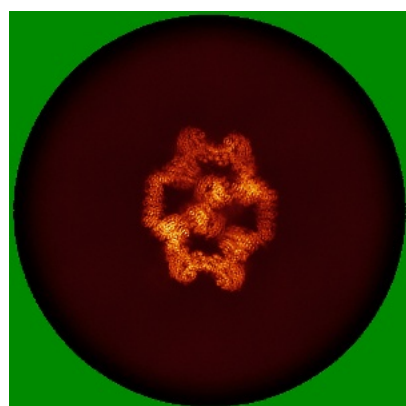

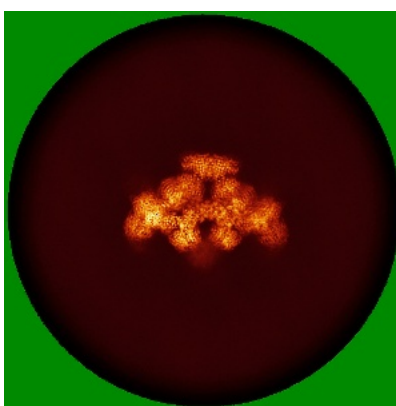

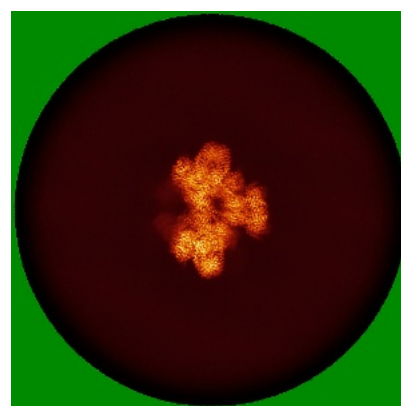

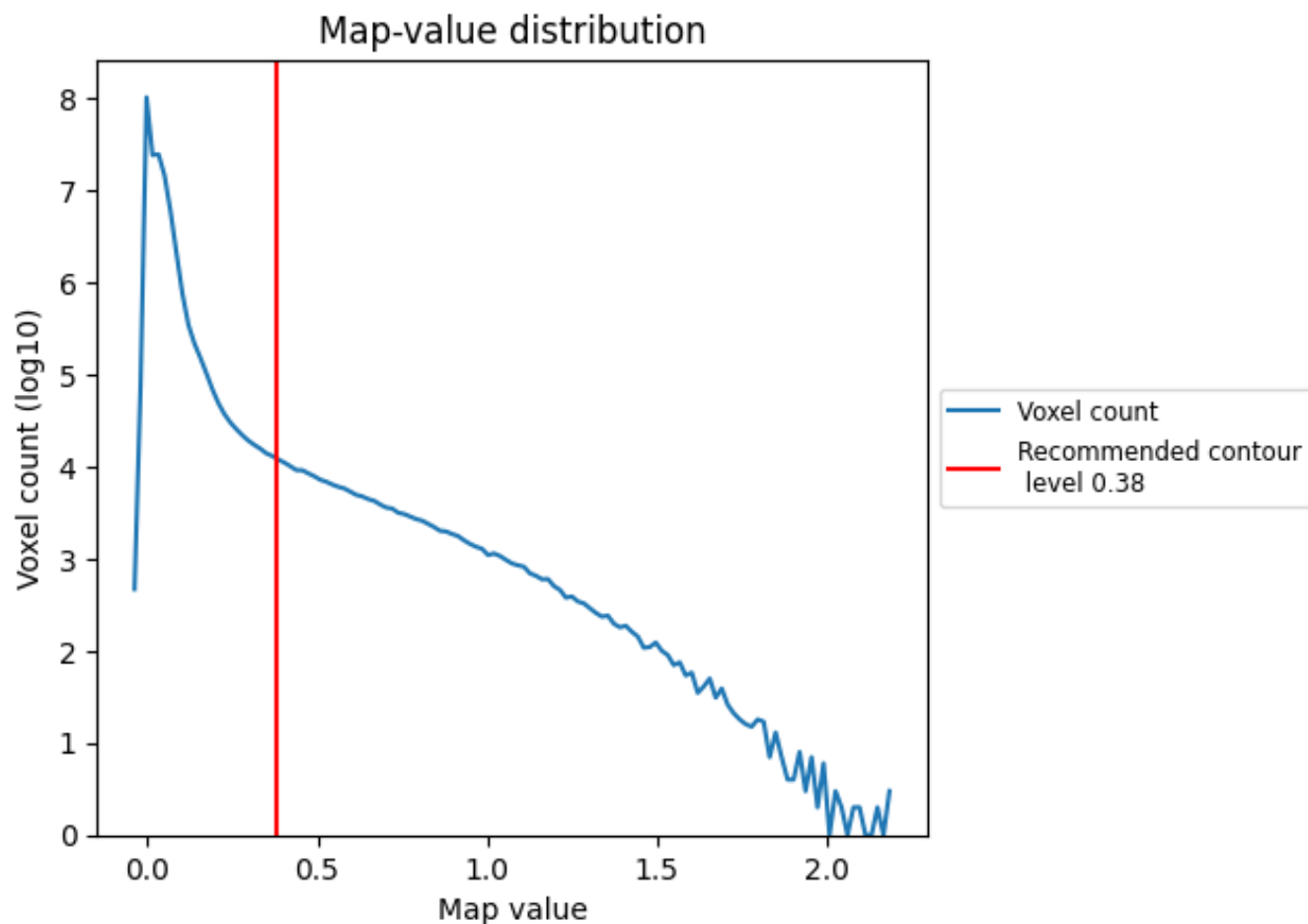

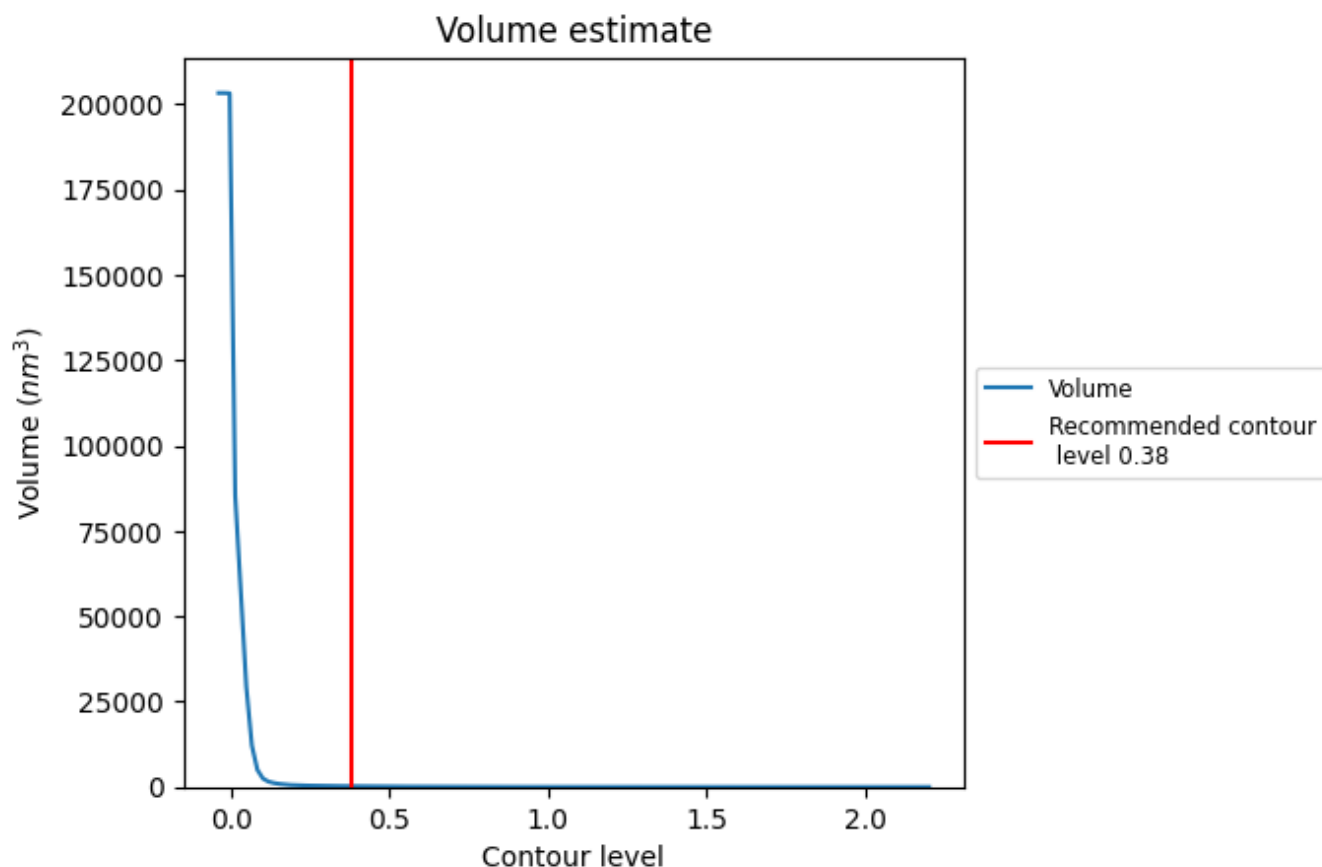

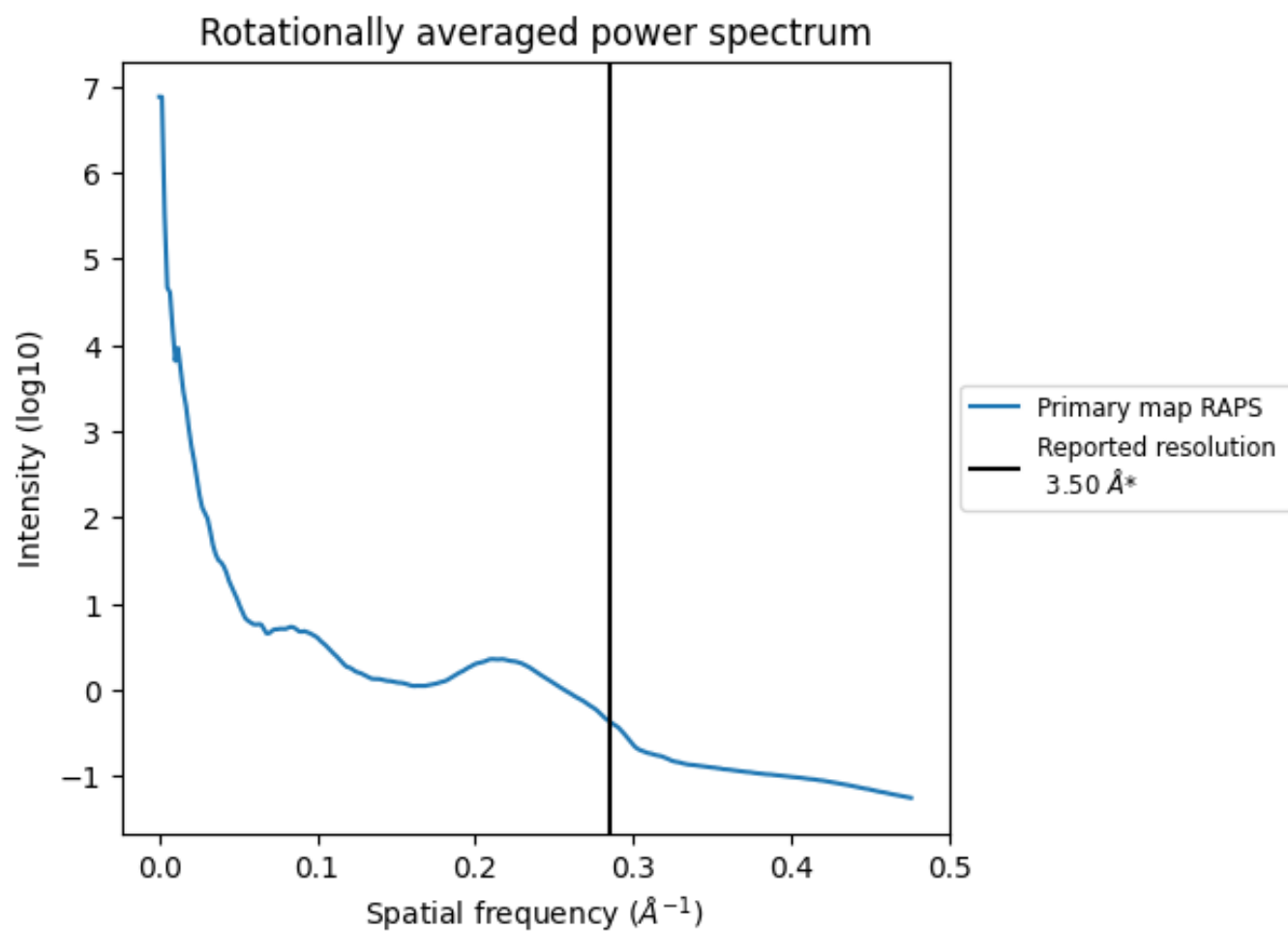
7.2 Volume estimate [i](#)

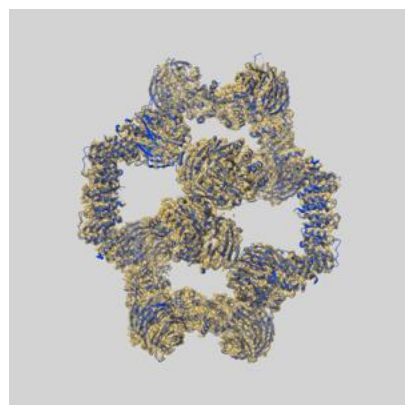

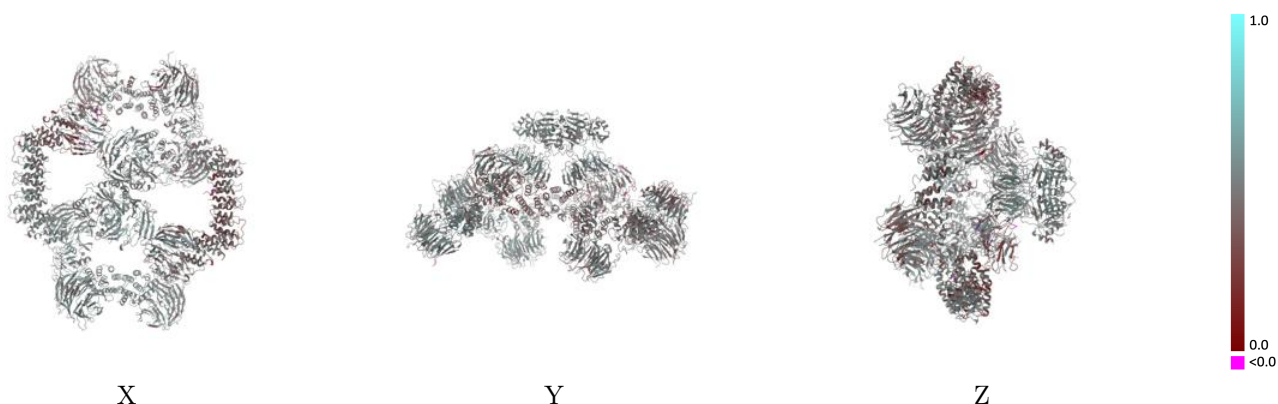

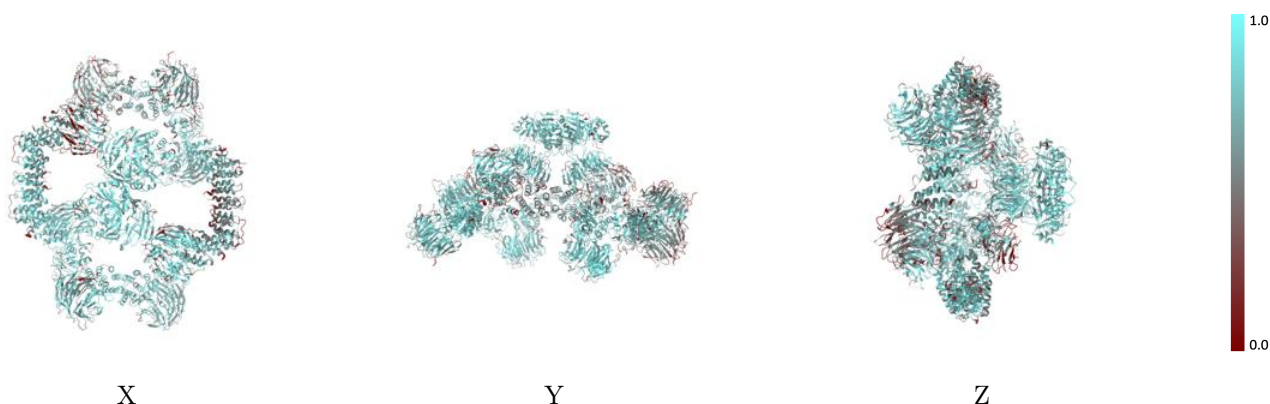

9.2 Q-score mapped to coordinate model [i](#)



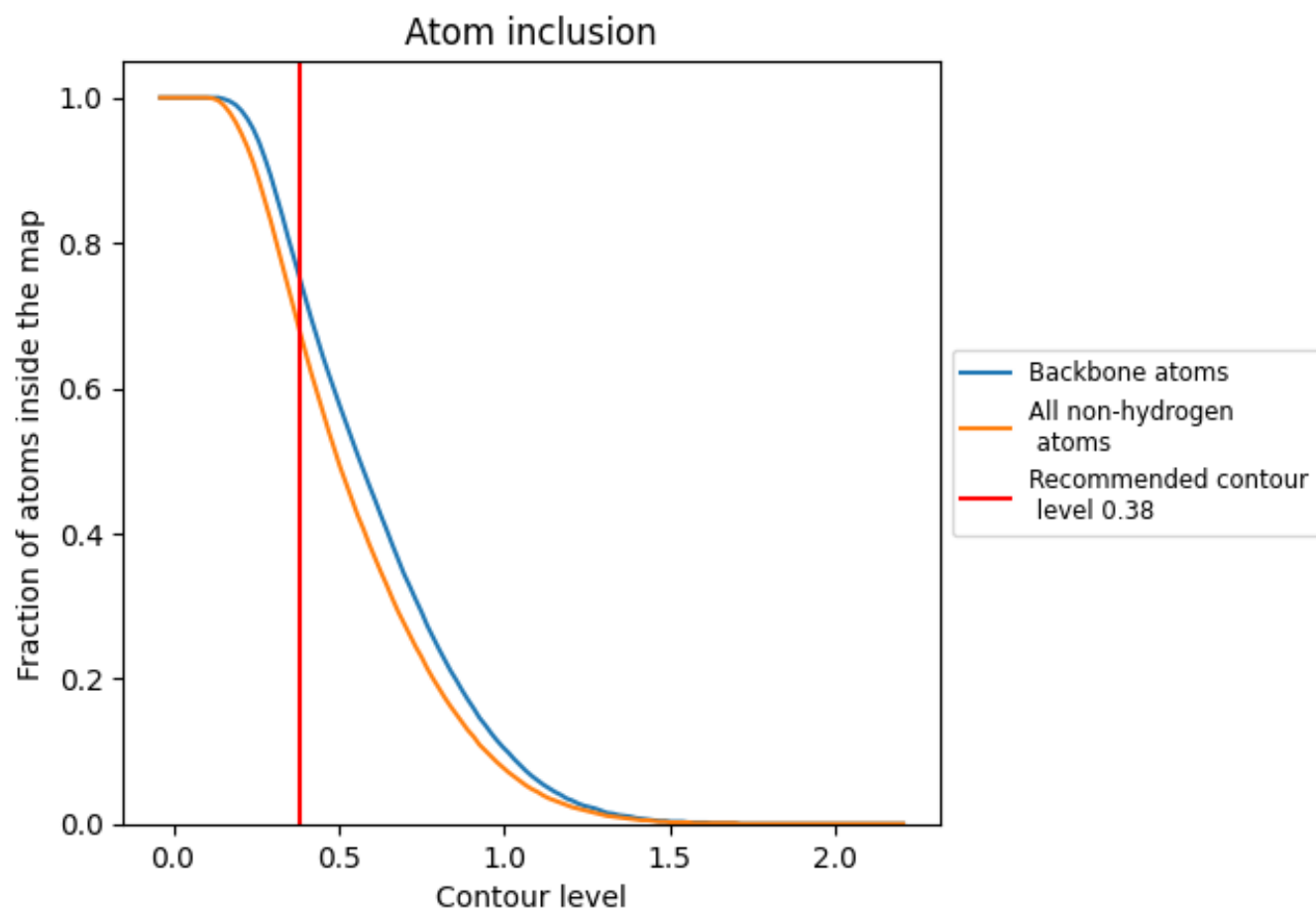
