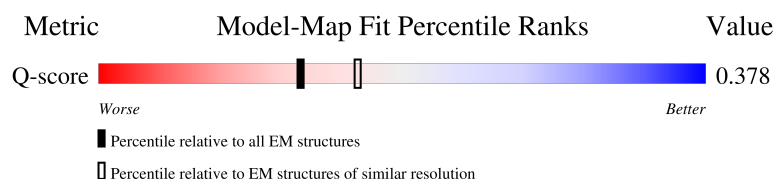
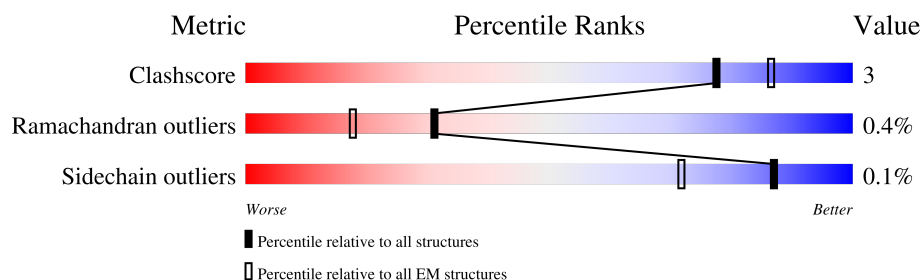

1 Overall quality at a glance

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

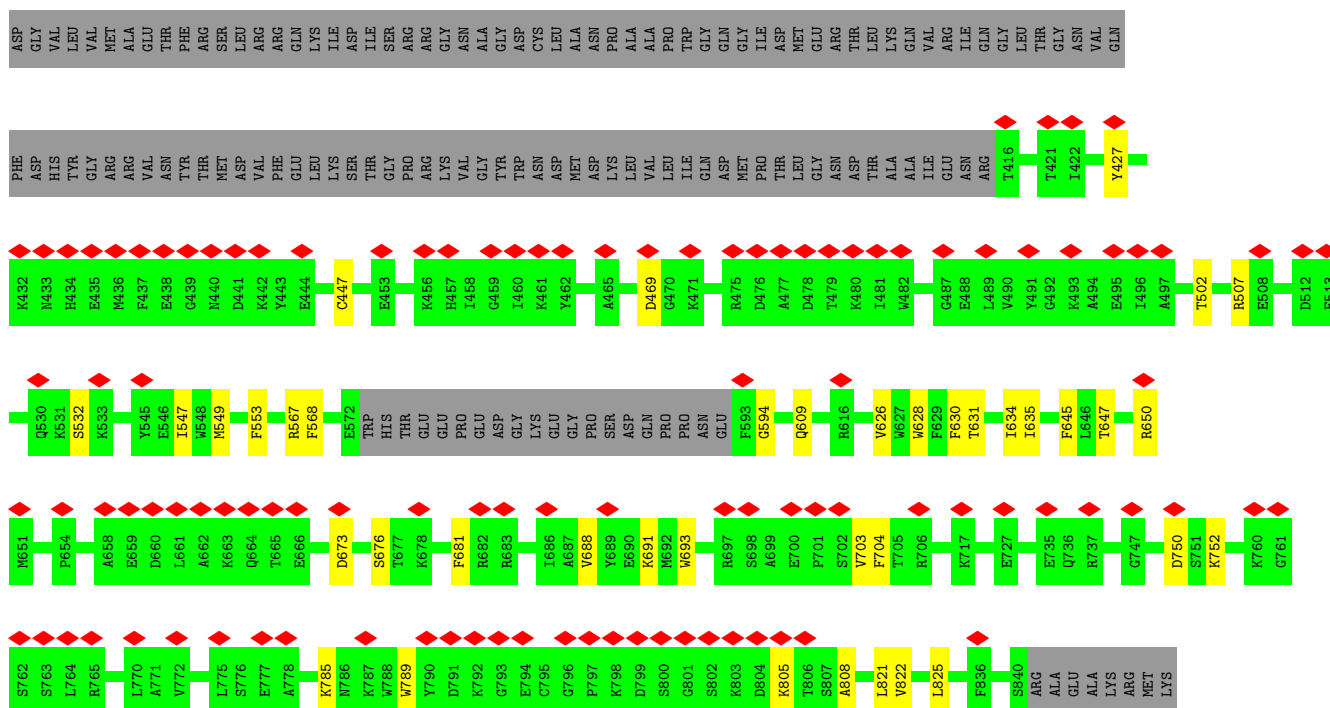


• Molecule 1: Isoform 2 of Glutamate receptor 4

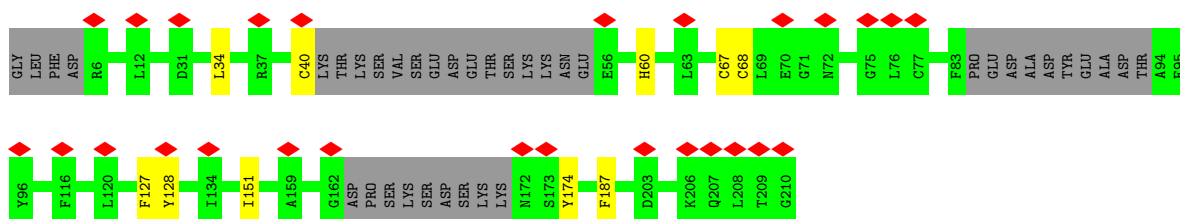
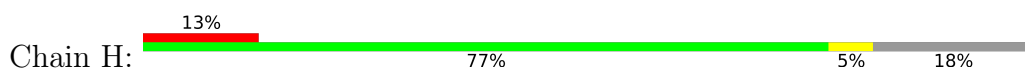

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. 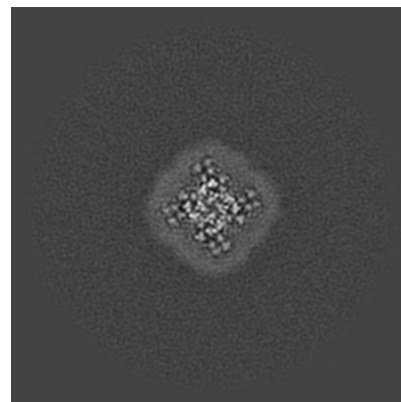

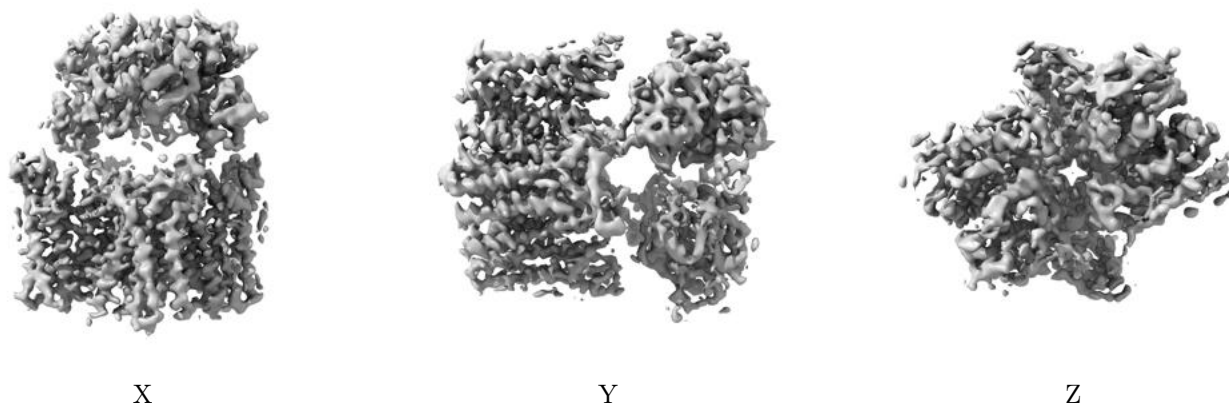

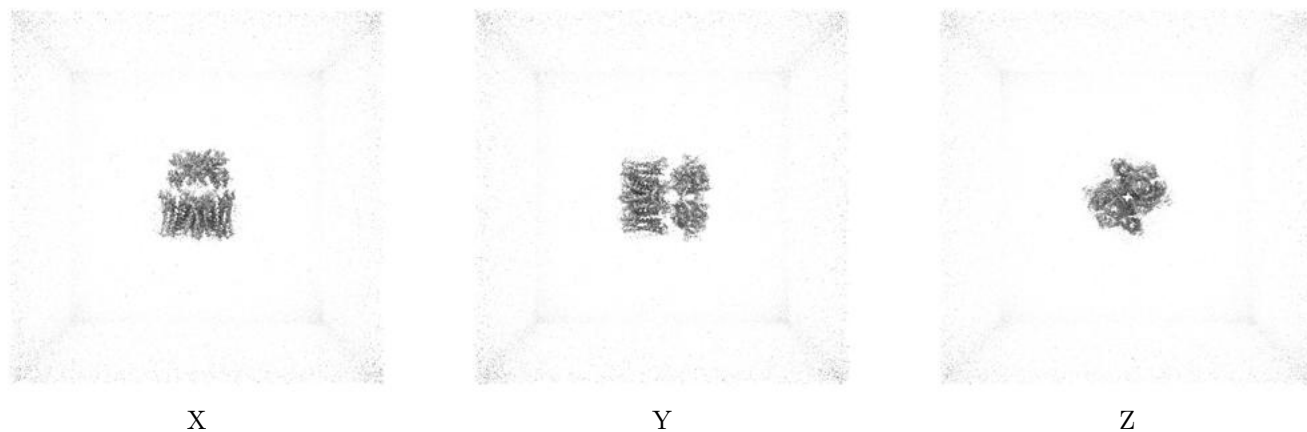

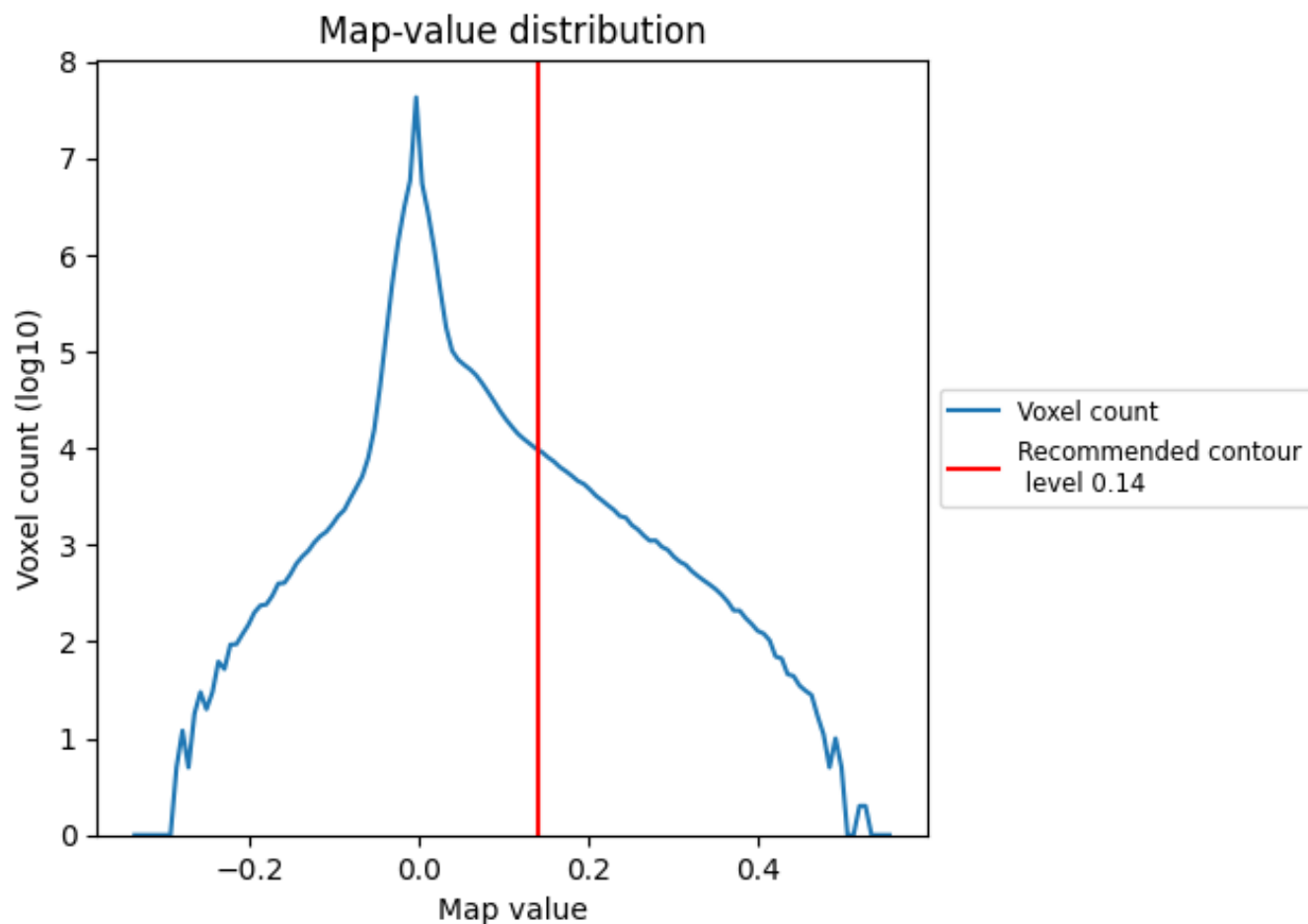

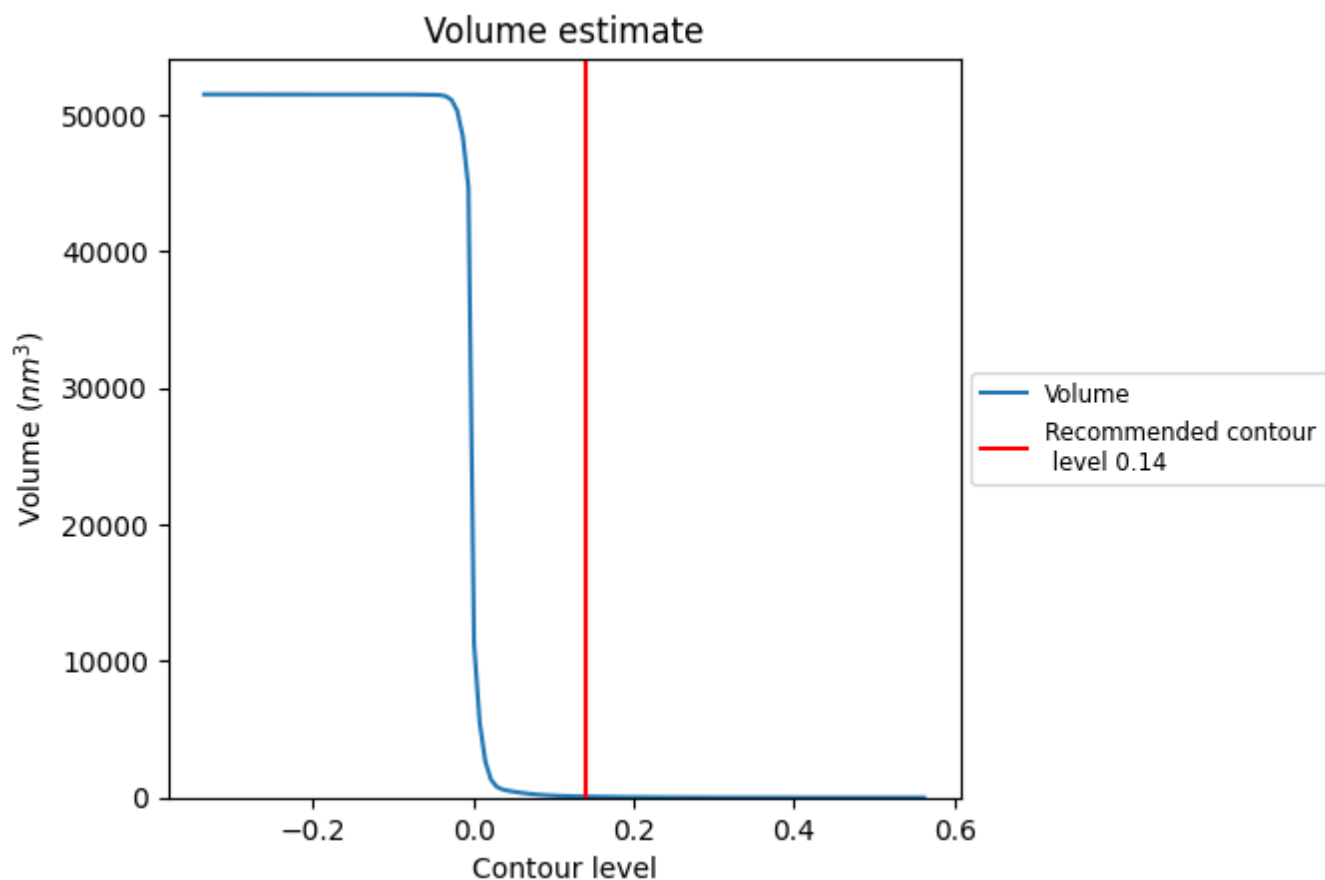

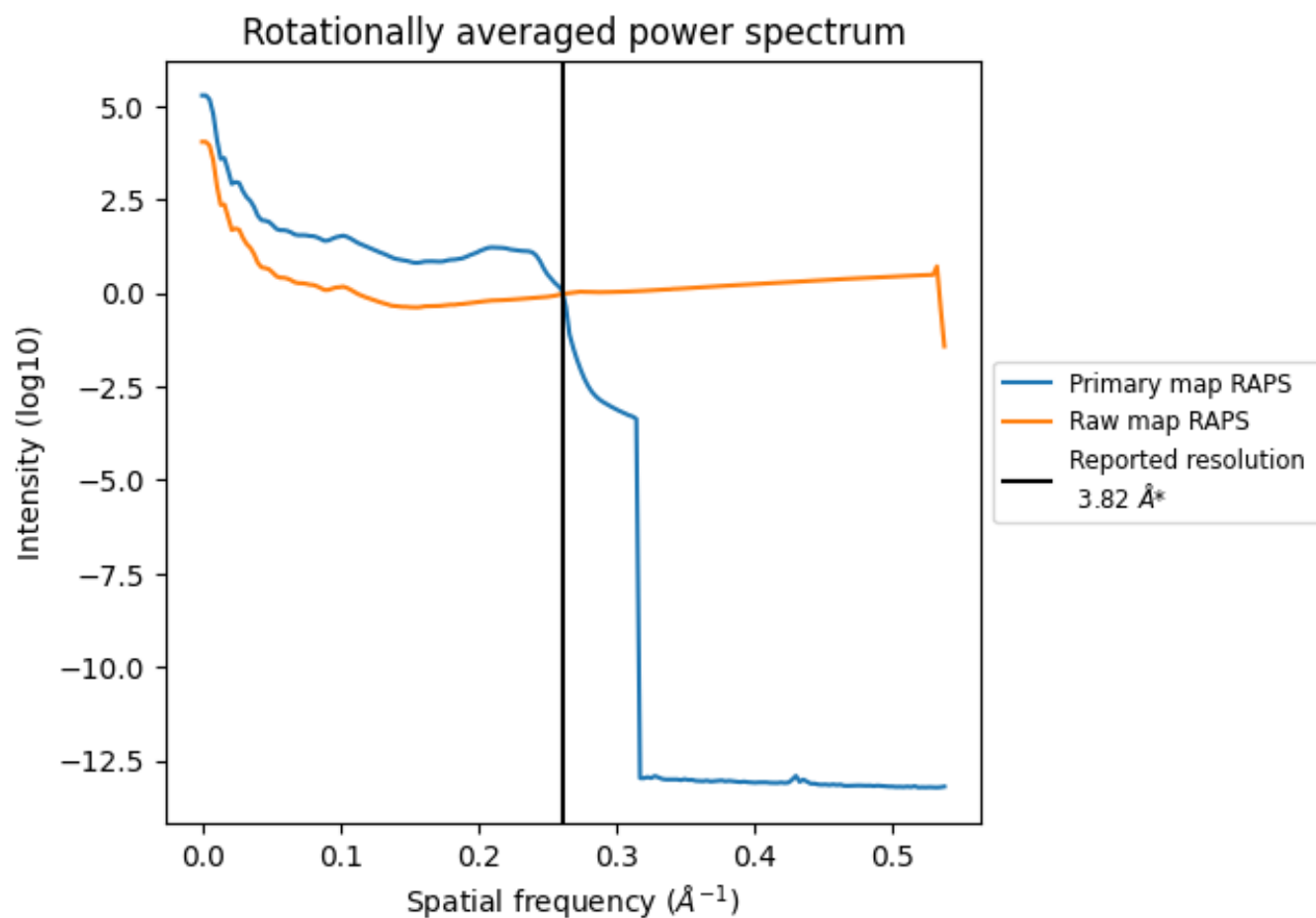

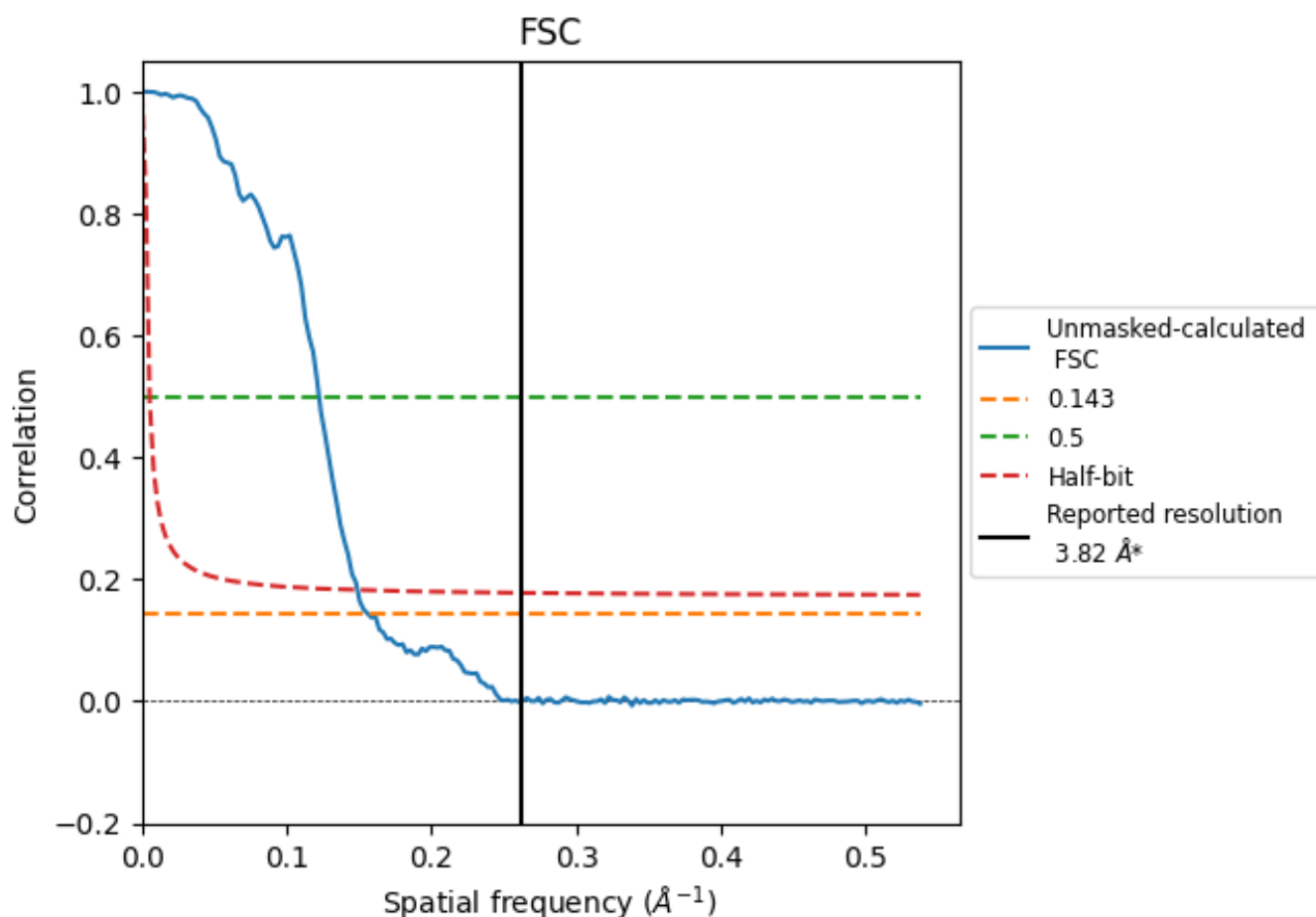

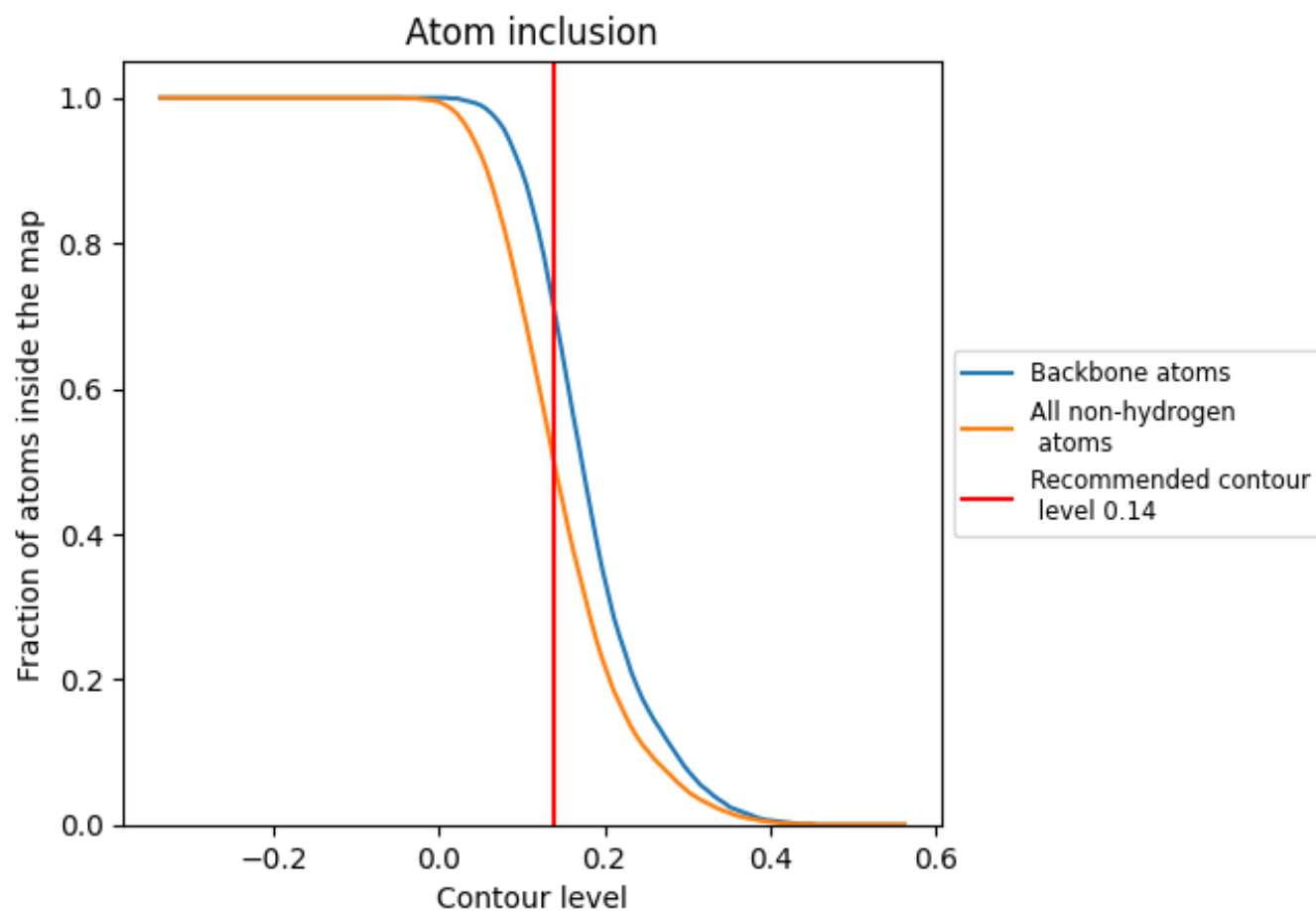

The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.14).

At the recommended contour level, 70% of all backbone atoms, 49% of all non-hydrogen atoms, are inside the map.
